



## **INSTRUMENT OF GOVERNMENT**

## FEDERATED GOVERNING BODIES

## All Saints' C of E Junior School and Emscote Infant School Federation.

- 1. The name of the Federation is All Saints' C of E Junior School and Emscote Infant School Federation.
- 2. The names and categories of the schools within the Federation are

All Saints' C of E Junior School and Emscote Infant School

- 3. The name of the governing body is **The Governing Body of All Saints' C of E Junior School and Emscote Infant School Federated Governing Body.**
- 4. The governing body shall consist of :
  - 2 Parent governors
  - 1 Local Authority governor
  - 1 Staff governor
  - 1 Headteacher
  - 3 Foundation governors (including ex-officio governors)
  - 10 Co-opted governors
- 5. The total number of governors will be **18**
- 6. The term of office for all governors is **four** years.
- 7. Parent governors will be elected as follows:

1 parent governor from Emscote Infants 1 parent governor from All Saints Junior

8. Foundation governors shall be appointed by the Coventry Diocesan Board of Education in consultation with the Parochial Church Council of All Saints, Emscote, Warwick.

a) The holder of the following office shall be a foundation governor ex-officio: incumbent of the parish. (b) The Diocesan Director of Education and the appropriate Archdeacon shall appoint a foundation governor to act in place of the ex-officio foundation governor whose governorship derives from the office named in a) above, in the event that the ex-officio governor is unable or unwilling to act as a foundation governor, or has been removed from office under regulation 21(1) of the Regulations.

- 11. The Diocesan Director of Education and the appropriate Archdeacon are entitled to request the removal of any ex-officio foundation governor and to appoint any substitute governor.
- 12. Statement of Religious Ethos:
- 13. All Saints' is a Church of England School and its values are determined by its Christian ethos. It seeks to be distinctively Christian yet inclusive of people of all faiths and none. It is part of the family of Church Schools within the **Diocese of Coventry** and is supported by the **Diocesan Board of Education**.
- 14. This Instrument of Government comes into effect on July 2015
- 15. This Instrument was made by order of Warwickshire Local Authority on May 2015
- 16. A copy of this Instrument must be supplied to every member of the governing body (and the Headteacher if not a governor), the trustees of the foundation of the schools within the federation and the Diocesan Director of Education for Coventry Diocesan Board of Education.
